APPLICATION MADE UNDER THE FREEDOM OF INFORMATION ACT 1991

I refer to your application made under the *Freedom of Information Act 1991* (the FOI Act) received by the Department for Industry, Innovation and Science (DIIS) on 12 April 2023, seeking access to:

"An index detailing how many business visa nominations were submitted, approved and rejected (not nominated) between August 2022 and March 2023, including the reason for rejection, and copies of any correspondence provided to the applicant informing them of the decision to reject."

Date range: 1/08/2022 to 31/03/2023

A search of the DIIS Dynamics 365 Customer Relationship Management (CRM) system was undertaken to identify records within scope of your application. Section 4(5)(a)(b) of the FOI Act provides that where an agency holds information in computer storage, and a particular document is capable of being provided by the computer on the basis of information so stored, the agency is to be taken to hold that document. Therefore, in accordance with Section 4(5)(a)(b), the data has been extracted from the CRM system and captured in the attached table.

For the period 1 August 2022 to 31 March 2023, there were 104 applications submitted for state nominated business visas. To be nominated for a state nominated business visa, applicants must meet all state nomination requirements, as well as the Department of Home Affairs eligibility criteria. An application is refused when it has not met one or more of these requirements.

The Department assesses each application against these requirements and criteria before deciding on the outcome. If an application does not meet the requirements and criteria, their

application is refused. In this case, the applicant receives a generic system generated notification advising there has been a change to the status of their application and prompting them to access their online their Skilled and Business Migration Portal account for more information.

Where the application has been rejected the online portal is the only avenue in which the applicant can find details relating to the requirements and/or criteria which has not been met, specific to their individual application. Therefore, I have determined there are no documents within this section of the scope of your application.

No fees and charges are payable for the processing of this determination in accordance with Section 53(2)(b) of the FOI Act.

In compliance with Premier and Cabinet Circular PC045 - Disclosure Logs for Non-Personal Information Released through Freedom of Information (PC045), DIIS is required to publish a log of all non-personal information released under the Act.
