DETERMINATION MADE UNDER THE *FREEDOM OF INFORMATION ACT 1991*

I refer to your application made under the *Freedom of Information Act 1991* (the FOI Act) received by the Department for Industry, Innovation and Science (DIIS) on 9 May 2023, seeking access to:

"All letters, emails or other documents from Hon. David Pisoni regarding usage or tenancy arrangements for "Artisan Post Group", "Convergen" or "Jumpgate VR" at Adelaide Studios."

From 17/03/2018 to 22/03/2022.

A search for documents held by DIIS was undertaken and one document was discovered within scope of your application.

I have reviewed the document and have determined to grant you partial access in accordance with clause 6(1) of Schedule 1 of the FOI act.

Clause 6(1) Documents affecting personal affairs, provides that a document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead). Therefore, I have determined it would be unreasonable to disclose the email addresses of the individuals in the document I am releasing to you.
