APPLICATION MADE UNDER THE FREEDOM OF INFORMATION ACT 1991

I refer to your application made under the *Freedom of Information Act 1991* (the FOI act) received by the Department for Industry, Innovation and Science (DIIS) on 9 May 2023, seeking access to:

"All lists of stakeholders used by the Department when seeking to consult with stakeholders and interested parties in relation to Creative Industry and or music policy and/or grants. Such a list would be held by one of the directorates reporting to Minister Michaels. If there is one consolidated list that is used by the Department as its standard list then this will be sufficient. While understanding that some personal details of individual stakeholders (where they are not public servants) may need to be redacted, if they are associated with an organisation I would expect at least their title and the organisations's name to be included."

Further communication with your office on 22 May 2023 provided the following clarification on the scope of his application:

".... remove individuals who are acting in their own right rather than being a part of an organisation. In relation to a date range, John would be pleased to have any current list available, however, if not, he would like the date range 1st of January 2022 to present."

A search for documents held by DIIS was undertaken and one document was discovered within scope of your application.

I have reviewed the document and have determined to grant you partial access in accordance with clause 6(1) of Schedule 1 of the FOI act.

Clause 6(1) Documents affecting personal affairs, provides that a document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead).
